According to the Consular Charter of the Russian Federation, the following citizens are exempted from consular tariffs payment: Heroes of the Union of Soviet Socialist Republics, Heroes of the Russian Federation and full knights of the Order of Glory, participants and invalids of the Great Patriotic War, the citizens with the medals "Resident of Leningrad Blockade", the citizens injured due to the accident at Chernobyl atomic power station, as well as due to the other radiological or technological disasters.

Due to the variable currency rate of USD to BWP the course of 11,00 BWP for 1 USD is fixed for the calculation of all consular tariffs in pula.
